# R IMMEDIATELY AFTER THE ACCIDENT

- Check for injuries; call 911 when in doubt. If you are injured immediately seek medical attention.
- Gather the information listed on the opposite pages. Write down as much of this information as you can at the accident scene.
- Call the police and insist that they take a report, even if the accident seems minor.
- Write down the name, address, and phone number of every driver, witness, and passenger.
- Do not discuss the accident with anyone except to answer questions asked by police officers.

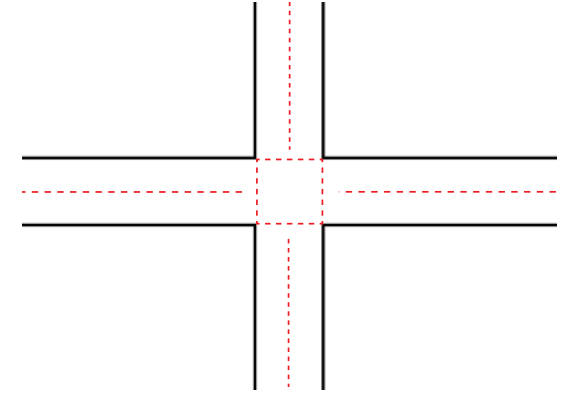
